

Corridor Advisory Committee Meeting #1 Alternative Component Map Results and Summary

The first Corridor Advisory Committee (CAC) Meeting for the Wolf Road Corridor Study, from 79th Street to Plainfield Road, was held on Wednesday, December 13, 2023, at the Indian Head Park Village Hall. The purpose of the meeting was to introduce the Study, establish the CAC, review existing conditions, share public survey results, discuss potential corridor alternative components, and receive feedback from CAC members. Twenty-eight (28) participants were in attendance, each of which was provided the meeting agenda, CAC description handout, member list, presentation, and corridor aerial map. After CAC Meeting #1, members of the CAC and the public had the opportunity to review and provide feedback on the potential components that could be included in the preliminary alternatives: roadway section type, turn lanes, sidewalk, shared-use path, on-street bicycle lanes, and more. This feedback was collected through February 9, 2024, using the corridor aerial map discussed at the meeting. A total of 142 map responses were collected, including 16 responses from CAC members, one response from a Homeowners Association, and 125 responses from interested members of the public.

This alternative component map feedback will be used in conjunction with the other feedback collected throughout the Study to provide directional input to the Study Team on how the CAC and public feel regarding the different potential alternative components.

The summaries that follow provide a breakdown of responses from CAC members, the Homeowners Association, and interested members of the public for the three corridor segments: 79th Street to 72nd Street, 72nd Street to Joliet Road, and Joliet Road to Plainfield Road. Not all respondents provided feedback for all three corridor segments and that is reflected in the summary tables below.

CAC Responses Summary (16 Responses)

Responses were provided by the Village of Indian Head Park, Village of Burr Ridge, LaGrange Highlands School District 106, Pleasantdale School District 107, Pleasant Dale Park District, Flagg Creek Water Reclamation District, LaGrange Highlands Sanitary District, an Indian Head Park business owner, Indian Head Park residents, and a Burr Ridge Resident.
